

## Nevada STEM Networks Funding Application

## **About**

<u>Eligible Applicants</u> – Any organization which seeks to deliver outstanding STEM programming to the community.

<u>Actions of the Nevada STEM Network</u> – The Nevada STEM Networks has received funding from the Governor's Office of Science, Innovation, and Technology to support STEM programming in three ways:

**Scale-Up** existing STEM programming to reach more students and community members in its originating STEM Network region.

**Extend** existing STEM programming to another STEM Network region. In this case the application should be directed to the STEM Network in which the program will be sent to.

**Pilot program** funding for organizations that are seeking to create novel approaches to meet STEM programming gaps in their respective STEM Network region.

<u>Types of Programs</u> – STEM programming can be described as any curriculum, prepackaged lessons, camps, professional development, work based learning, and other established STEM educational opportunities.

<u>Program Evaluation</u> – The Nevada STEM Network requires that all supported programs assist in evaluating programming outcomes. The nature of this evaluation is contingent on the type of STEM programming that is being proposed. Possible evaluation measures include, but are not limited to, distribution of surveys, participant counts, and collection of demographics.

Allowable Use of Funds – Requested funds may be divided amongst foreseeable program expenses as the applying organization sees fit. No cap is placed on personnel related expenses (e.g., salaries) and program related expenses (e.g., materials, transportation, supplies, etc.) to provide greater creative freedom for applicants. An indirect cost or F&A of up to 5% is not required but may be applied prior to calculating the percentages for salaries. It is requested that part of the budget narrative (Q 13) speak directly to the rationale behind how the funds are divided.

<u>Unallowable Use of Funds</u> – Funds may not be used for food, drink, or alcohol. Any awarded funding shall not be used to supplant existing funds nor should it be used for projects, initiatives, or activities that do not align with the vision of the Regional STEM Network. Lastly, funding may not be used to purchase supplies or travel which exclusively benefits members of the applying organization and does not support the STEM program which is seeking funding.

<u>Awards Process</u> – Submitted applications will be reviewed by the region's respective STEM Network Advisory Committee. It is up to the discretion of this committee to identify high value STEM programs which are well positioned to make use of STEM Network funds. The network accepts applications on a rolling basis with awards being made as frequently as each month. Grant requests can be made in amounts ranging from \$1,000 up to \$40,000.

<u>Funding Spend-Out Requirement</u> – If funds are awarded the applying organization must spend all requested monies by June 30<sup>th</sup>, 2020. This is in accordance with the state of Nevada's fiscal year budgeting requirements.


