Special Construction Amortization:
 The Second E-Rate Modernization Order (FCC 14-189) included a four-year (FY 2015 – FY 2018) suspension of the requirement that special construction costs over \$500,000 be amortized over a period of at least three years. It is unclear if the FCC will extend the suspension for projects initiated and funded in FY 2019 and beyond. If the FCC does NOT extend the suspension of the amortization requirement, the bidder must be aware that the applicant will only be able to request funding for one-third of the special construction in FY 2019, one-third in FY 2020, and one-third in FY 2021. Because of this uncertainty, a bidder offering solutions with special construction charges over \$500,000 must provide two (2) distinct proposals to address the alternative amortized and non-amortized scenarios.
