**Narrative**

Pershing County Schools, as the lead in a consortium with the Pershing County Library, is requesting proposals for self-provisioned fiber construction and services over third party networks for delivery of wide area network (WAN) services to the district, including special construction costs, maintenance and operation costs associated with network equipment, as required, as detailed in the attached RFP documents. Services over third-party networks includes considering any type of technology neutral, point-to-point broadband service delivered over a service provider or other third-party owned network. The current WAN services are provided by district owned multi-mode dark fiber. Bidders must complete the attached PCSD Pricing Sheet and return it with each proposal by the advertised bid closing date. See attached RFP for all specifications and requirements.
