The public body may place reasonable restrictions on the time, place, and manner of public comments but may not restrict comments based upon viewpoint.

NOTE (2): Per the Declaration of Emergency Directive 044 Pursuant to Section 8, Notwithstanding any delegation of authority pursuant to this Directive, certain mitigation measures shall remain in place and will continue to be managed and enforced by the State, including but not limited to: ...Open Meeting Law Provision as originally set forth in Directive 006.

NOTE (3): Per the Declaration of Emergency Directive 006 Pursuant to Section 3, the requirements contained in NRS 241.020(4)(a) that public notice agendas be posted at physical locations within the State of Nevada are suspended.

NOTE (4): Section 1 of the Declaration of Emergency Directive 006 Pursuant to Section 3, the requirement contained in NRS 624.020(4)(a) that public notice agendas be posted at physical locations within the State of Nevada has likewise been suspended. No action may be taken upon a matter raised under the public comment period unless the matter itself has been specifically included on an agenda as an action item. Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process of individuals; the Board may refuse to consider public comment. See NRS 233b.126.
