To promote STEM education in Nevada, the Governor's Office of Science, Innovation and Technology, the Regional STEM Networks and the Nevada Department of Education are proud to host the STEM Teacher of the Year Program. We are seeking Nevada STEM teachers and advocates who have demonstrated exemplary STEM leadership and/or teaching practices, positively impacting Nevada's students, to recognize and promote for their work advancing the State's STEM goals.

<u>Teacher</u> is defined as a certificated PK-12 teacher currently employed at one of Nevada's public, private, or charter PK-12 schools.

An <u>advocate</u> is defined as a leader who helps to advance STEM in their region and/or state. Advocates might include, but are not limited to, school administrators, non-certificated school staff, volunteers, or employees of informal STEM education organizations.

Each region will select a winner, who will receive recognition, a digital seal, and a swag bag. Each State winner, selected from the pool of regional winners, will receive an additional prize of \$500.

Key Dates:

- 1. Application Packets are due by 5pm PST, February 12, 2024.
- 2. Up to one STEM teacher and up to one STEM advocate per region (Northwestern, Southern, and Rural) are announced by March 2024.
- 3. One State STEM Teacher of the Year and one State STEM Advocate of the Year will be selected from regional winners and announced by May 2024.

To be considered for the STEM Teacher or Advocate of the Year, please submit an application packet by the deadline. A complete application packet includes:
