WHAT IS IT?

E-RATE IS THE NATION'S LARGEST EDUCATION TECHNOLOGY FUNDING PROGRAM FOR K-12 SCHOOLS AND LIBRARIES ENSURING AFFORDABLE ACCESS TO TELECOMMUNICATIONS AND INTERNET.

- Established by the Telecommunications Act of 1996
- The Federal Communications Commission (FCC) is in charge of the E-rate program
- The Universal Service Administrative Company (USAC) administers the E-rate program based on FCC rules
- \$49.2B have been approved since the program started in 1998

COMMON BARRIERS TO E-RATE PARTICIPATION

 Lack of knowledge of the E-rate program

 Uncertainty surrounding CIPA compliance and E-rate requirements

 Small dollar applications are not worth the administrative burden by library staff





STRATEGIES TO OVERCOME BARRIERS

- Conference calls hosted by the State Library & the NV State (OSIT) E-rate Engagement Team
- Step-by-step handouts for specific program tasks and Form filing
- Live and recorded webinars providing targeted training on E-rate processes
- Dedicated E-rate Team available to assist in every aspect of the program

E-RATE IS:

A way to save 20-90% on Internet access and networking hardware costs

A vehicle to get better and/or faster Internet to and throughout your library

A reimbursement program based on approved expenditures

E-RATE IS <u>NOT</u>:

- A grant program
- A loan program
- A one-time application process



USAC refers to the funding year as the year in which services begin <u>FY2019:</u> July 1, 2019 – June 30, 2020

E-RATE FUNDING YEARS



FUNDING CAP

The E-rate funding cap for FY2018 was \$4.1B

Pre-FY2015 the cap was limited to \$2.3B

Nearly doubling the fund has lead to all bona fide requests being funded

E-RATE BENEFICIARIES

Libraries and Library Systems

- All public libraries
- Non-profit libraries accessible to the public
- Separate budget from any school and must be eligible for LSTA assistance

Schools and School Districts

- Supporting K-12 education
- Must be considered a school by the state
- Including Charter or Virtual schools

Consortia

 Can be created with members from schools, school districts, libraries or a combination of each entity type

E-RATE DISCOUNTS

- Discounts range: 20% to 90% for Category 1 services 20% to 85% for Category 2 services
- School/School District: determined by the percentage of students in the district that qualify for free or reduced price lunch
- Library/Library System: determined by the school district in which the main branch is located
- Last year, Nevada school districts were eligible for 60-90% discounts

SERVICES ELIGIBLE FOR E-RATE FUNDING

Category One (C1)

Data Transmission and/or Internet Access

- Leased Lit Fiber, Leased Dark Fiber, Self-Provisioned Network
- Fixed Wireless Broadband
- Cellular Data Plans for Bookmobiles





BROADBAND CONNECTIVITY TARGET

 The American Library Association (ALA) recommends minimum bandwidth speeds for libraries. Adopted by the FCC for E-rate program applicant libraries

• For libraries serving 50,000 or fewer patrons, at least 100 Mbps

• For libraries serving more than 50,000 patrons, at least 1 Gbps

• Urban libraries have a natural advantage in achieving these targets

• Rural libraries may require assistance in achieving these speeds

SERVICES ELIGIBLE FOR E-RATE FUNDING

Category Two (C2)

- Internal Connections
 - Equipment necessary to extend broadband within the library (in-building WiFi Networks)
- Managed Internal Broadband Services
- Basic Maintenance of Internal Connections
- Category 2 is subject to a five (5) year budget





CATEGORY 2 BUDGET

- Each library has a five-year, pre-discount budget for those products and services based on the number of square feet of the library branch (outlet)
 - The majority of NV libraries will have a \$2.39/sq. ft budget
 - IMLS locale codes 11,12, or 21
 - e.g. Las Vegas libraries are eligible for a \$5.20/sq. ft budget
 - Minimum Category Two budget is \$9,582
- May spend all of its C2 budget in one year or over any of the five year period
- Can be used to purchase networking hardware such as:
 - wireless access points
- Cabling

- **o** routers
- **u** switches

- Girewalls
- UPS/battery backups



TIMELINE FOR FY2019-20



NOW! Deadline before Form 471 Filing Window opens in early January

July 1, 2018 – Early February 2019

Form 471 Filing Window TBD, Estimated early January – Mid-March 2019

Estimated April – September 2019

Deadline: 120 days from first day to receive service or FCDL, whichever is later

Deadline: 120 days from last day to receive service



IMPORTANT UPCOMING DEADLINE

- <u>Now Through Early January</u>: Administrative Window for creating new EPC entities, associate branches with main library, updating profile entity information
 - Add or remove entities
 - Any other entity changes such as address updates, etc.
 - Add locale code and square footage
- <u>No changes</u> allowed once Form 471 Filing Window opens (in early January)
- Best opportunity to update information in your profile.
 - If the deadline is missed, can lead to downstream problems and complicated RAL Changes.

E-RATE FORMS AND PROCESS

Form 470 (July 1 – early February) filed before the start of the funding year

• Initiates request for bids, "wish list"

Form 471 (early January – mid-March) filed before the start of the funding year

E-rate application for funding

Form 486 (no later than 120 days after funding commitment (FCDL))

- Notifies the program administrator that services have started
- Certifies CIPA compliance status

Form 472 (BEAR) (July 1 - October 28)

- Reimbursement to the applicant is submitted by the applicant when the service provider invoice is paid in full
- <u>OR</u> Form 472 (SPI) (July 1 October 28) Reimbursement to the service provider is submitted by the service provider when the applicant is invoiced the discounted price

<u>OPTIONAL</u> Form 500 (Before service delivery deadline)

submitted when changes need to be made to approved funding requests





CIPA CHILDRENS INTERNET PROTECTION ACT



CHILDREN'S INTERNET PROTECTION ACT

- The Children's Internet Protection Act
 - <u>Purpose</u>: protect minors from visual images that are obscene, child pornography or harmful content
- CIPA compliance is required of applicants requesting funding for:
 - C1 Internet access
 - C2 internal connections, basic maintenance of internal connections and MIBS
- ALA recommends that libraries do its best to minimize the impact of filters by
 - Selecting the most flexible filter possible
 - Maintaining as much local control as possible
 - Using the lowest, simplest settings possible



CHILDREN'S INTERNET PROTECTION ACT

Internet Safety Policy (ISP)

- A library adopts an Internet Safety Policy (ISP) describing its protection of minors from offensive and harmful Internet content.

Public Notice

- Address publicly the library's adoption of its ISP in compliance with CIPA
- Keep copies of the meeting agenda and minutes

Filter

- Maintain a technology protection measure that filters obscene and inappropriate images from computers with Internet access
- Keep copies of filter log or screen shot showing filter in place and invoice for the filter



WHAT CIPA REQUIRES

• ADULTS

• The filtering must be set to block *visual images* that are obscene or child pornography

MINORS

- The filter must be set to block visual images that are obscene, child pornography or harmful to minors
- CIPA uses the federal criminal definitions for obscenity and child pornography. The term
 "harmful to minors" is defined as "any picture, image, graphic image file, or other visual
 depiction that (i) taken as a whole and with respect to minors, appeals to a prurient
 interest in nudity, sex, or excretion; (ii) depicts, describes, or represents, in a patently
 offensive way with respect to what is suitable for minors, an actual or simulated sexual act
 or sexual contact, actual or simulated normal or perverted sexual acts, or a lewd
 exhibition of the genitals; and (iii) taken as a whole, lacks serious literary, artistic, political,
 or scientific value as to minors."

WHAT CIPA DOES NOT REQUIRE

- Blocking access to <u>narratives or other text-based material</u>
- Blocking access to <u>controversial viewpoints or subjects</u>
- Blocking access to social media sites or search tools
- Tracking or monitoring users' web surfing habits

WASHOE COUNTY LIBRARY SYSTEM



- Use OpenDNS which is a Cisco product. They offer a service called Family Shield. <u>https://www.opendns.com/setupguide/#familyshield</u>
- Family Shield is <u>free for library use</u> as they do not use the produce to make money. (Government and Non-Profits have that option).
 - Service connects with Envisionware, a software product that manages Internet sessions on computers.
 - A guest pass or sign-on with a child card will automatically trigger Envisionware to activate the Family Shield filter without staff intervention. Adult users have a toggle option where they can turn the filter off without staff intervention.

NEVADA CONNECT KIDS INITIATIVE



NV CONNECT KIDS INITIATIVE

- The Nevada Connect Kids Initiative established a dedicated state match for special construction charges, matching up to 10% per project for special construction on a dollar-to-dollar basis.
- The FCC provides eligible applicants with an additional 10% discount for special construction charges, matching state funding for the project on a dollar-for-dollar basis.
 - Example #1: A library with an 80% discount can receive up to an additional 10% from the state match for the cost of the special construction project and an additional 10% from the FCC. This means the library pays *nothing* out of pocket for special construction charges.
 - Example #2: Tonopah Library District (Nye County) was able to upgrade from 5 Mbps DSL service to 100 Mbps in FY 2018. The special construction charges equaled \$9,950. The FCC contributed 95% and the State Match 5% since they qualified for a 90% discount.

 - E-rate applications (Forms 471) were filed by 5 library systems
 - Representing 31 branches
 - Realizing a cost savings of \$272,037.07 in E-rate discounts

- Approximately 50 applications filed
- On behalf of 90 individual libraries
- Realizing a potential cost savings of \$450,493.97 in E-rate discounts

FOR EXAMPLE: TEXAS STATE LIBRARIES



The Texas State Library and Archives Commission has received a special legislative appropriation of one million dollars to bring high-speed internet connections to Texas communities through their public libraries.

The funds allow TSLAC to facilitate local public library access to federal discounts that will make broadband connections affordable. The request was funded as part of the agency's 2018-2019 legislative appropriation.

Key factors:

- Currently, only 6 percent of Texas public libraries have Internet connections at speeds recommended by the Federal Communications Commission
- Public libraries are the only source of public Internet access for approximately 60% of communities
- Approximately 23% of Texas public libraries receive E-Rate discounts, compared to 65% of all U.S. public libraries



LIBRARIES CONNECTING TEXAS

Libraries Connecting Texas (LCT) Program Commencement Date: October 2017



- Texas has 646 public libraries
- In 2017-18, only 122 libraries filed for federal E-rate funds. The LCT Program began with Funding Year 2018-19 and 145 libraries file for E-rate, a 16% increase
- 50% of LCT participants had NEVER participated in the E-rate program
- On average, participating libraries increased their bandwidth <u>927%</u>
- The average new bandwidth is 245.23 Mbps and paying an average cost of \$5.84 per Mbps.



LCT: TALE OF THE TAPE

The LCT Program brought \$606,281.20 of federal E-rate funding into the state of Texas.

ELECTRA PUBLIC LIBRARY SERVING A POPULATION OF 2,722 WITH LCT: 1,567% SPEED UPGRADE

"I am so pleased with being a part of the LCT program. I knew we needed more speed in the library but I also knew we couldn't afford it.

When I started here in 2012 there were no children utilizing the computers in their section because of how slow the speed was. We were operating on 6 Mbps and when too many people were on it, it just slowed so far down you would time out of whatever you were doing. We went from 6 Mbps to 100 Mbps and it will only cost us what we paid for the slower speed internet due to the E-rate taking 80% of the cost. We had to update some things with our internet equipment but if you know what you are going to need the consultants can help you include that in your paperwork.

It has been a true life-saver for our library. It will open the door to so many new options. Would I do it all over again if I had that option? You better believe it. The consultants you got to help us are so amazing and make you feel so comfortable."

NEXT STEPS – GET STARTED



FY2019-20

E-RATE FIRST STEPS – THE TIME IS NOW!

- Step 1: Set up your E-Rate Productivity Center (EPC) Portal Account
 Call Client Service Bureau (CSB) at 888-203-8100
 - If needed, create a billed entity number for your library/district in EPC
 - Set up an Account Administrator and General Contact for your EPC account
 - If working with the State E-rate Team, create a consulting relationship and add users as full-rights
- Step 2: Draft and certify FCC Form 470 for Internet access.
 - Request bids for incremental pricing from your existing bandwidth up to the ALA recommended target bandwidth
 - Wait a minimum of 28 days before awarding a contract
- Step 3: Evaluate all bids received and award a contract
- Step 4: File FCC Form 471 when the Filing Window opens in January
