NOTE (4): Section 1 of the Declaration of Emergency Directive 006 Pursuant to Section 3, the requirement contained in NRS 624.020(4)(a) that public notice agendas be posted at physical locations within the State of Nevada has likewise been suspended. Notice of this meeting was posted on the Governor's Office of Science,

Innovation and Technology (OSIT) website (<http://osit.nv.gov>) and the Public Notice Website (<https://notice.nv.gov>).

NOTE (5): Per the Declaration of Emergency Directive 006 Pursuant to Section 2, ...if a public body holds a meeting by means of teleconference or videoconference and a physical location where members of the public can attend is not provided, the public body must provide a means for the public to provide public comment, and post that means on the public notice agenda posted in accordance with NRS 241.020. Public comment options may include, without limitation, telephonic or email comments. Public comments may be submitted to the Governor's Office of Science, Innovation & Technology to **Debra Petrelli at dpetrelli@gov.nv.gov** or by calling 775-687-0987. No action may be taken upon a matter raised under the public comment period unless the matter itself has been specifically included on an agenda as an action item. Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process of individuals; the Board may refuse to consider public comment. See NRS 233b.126.
