Sierra View Library, 4001 South Virginia Street (inside Reno Town Mall), Reno, NV 89502

- 25ms network latency commitment
- 10ms network jitter commitment
- There is no right of provider to limit or throttle the capacity of the circuit at any time for any reason

Bids should be for the following tiers of service: 10 Mbps, 25 Mbps, 50 Mbps symmetrical service for 1 year, 3 year and 5 year terms with two one-year optional renewals.

Service should meet the following service level agreement standards:

- Network Availability: the provider will make all reasonable efforts to ensure 99.95% network availability of each circuit.
- .25% frame/packet loss commitment
- 50 ms network latency commitment
- 10 ms network jitter commitment
- There is no right of provider to limit or throttle the capacity of the circuit at any time for any reason
