## **Funding Status – FY 2019**

USAC released Wave 18 for FY 2019 on Thursday, August 22<sup>nd</sup>. Funding totaled \$84.9 million including \$111.7 thousand for Nevada. Cumulative commitments through Wave 18 are \$1.47 billion including \$6 million for Nevada.

## Updates on USAC's E-Rate Productivity Center and Legacy System

### Form 498 Update, cont.:

Our <u>newsletter of August 19<sup>th</sup></u> contained an extensive article on USAC's request to applicants and service providers to update their Form 498s to include a new "Business Type" field. Two additional details should be noted, namely:

- The "Business Type," when added, does not currently appear in the online version of the newly certified Form 498 nor in the PDF version. USAC is working to correct this.
- Last Friday's News Brief, referenced below, notes that EPC is currently replacing the information in the Remittance Contact section with that of the General Financial Contact. If these two contacts are meant to be different, the incorrect duplication should be corrected before the Form 498 is certified. Again, USAC is working to correct this.

### **E-Rate Updates and Reminders**

#### Upcoming E-Rate Dates:

August 26	Deadline for submitting reply comments on the FCC's NPRM (FCC 19-46) regarding a possible cap on total funding of the Universal Service Fund ("USF".) (See our <u>newsletter of June 3<sup>rd</sup></u> .)
September 3	Deadline for submitting reply comments to the FCC's Notice of Proposed Rulemaking ("NPRM") on the future of Category 2 funding for FY 2020

and beyond (<u>FCC 19-58</u>). (See our <u>newsletter of August 19<sup>th</sup></u> for a summary of the initial comments.)

- September 3 Deadline for submitting initial comments on the FCC's draft Eligible Services List ("ESL") for FY 2020 (DA 19-738). Reply comments are due September 18<sup>th</sup>. (See our <u>newsletter of August 5<sup>th</sup></u>.)
- September 6 Deadline for submitting USAC invoice appeals related to reissued BEAR Notification Letters. (See our <u>newsletter of July 15<sup>th</sup></u>.)
- September 11 Form 486 deadline for FY 2018 funding committed in Wave 55. More generally, the Form 486 deadline is 120 days from the FCDL date or the service start date (typically July 1<sup>st</sup>), whichever is later. Other upcoming Form 486 deadlines are:

Wave 56	N/A (no commitments)
Wave 57	10/03/2019
Wave 58	10/11/2019

Note 1: Applicants missing any Form 486 deadline should watch carefully for "Form 486 Urgent Reminder Letters" in their EPC News Feed. These Reminder Letters afford applicants 15-day extensions to submit their Form 486s without penalty.

Note 2: The first Form 486 deadline for FY 2019, covering funding committed in Waves 1-10, will be October 29, 2019.

# USAC News Brief Dated August 23 – BEAR PINs

<u>USAC's Schools and Libraries News Brief of August 23, 2019</u>, reminds applicants planning to file BEAR reimbursement forms (Form 472s) for FY 2018 discounts that they will need two identifying numbers: their Form 498 ID and a Personal Identification Number ("PIN"). Applicants who do not already have PINs will need to request them following the instructions included in last Friday's News Brief.
