The White Pine County School District is requesting proposals for the following services:

- 1. Self-provisioned fiber construction OR services provided over third-party networks for transport (WAN) service to the district, providing 10 Gbps bandwidth. The current point to point circuit from the District hub to the PoP is district-owned fiber, however enhanced services are now required to support rapidly growing bandwidth needs to replace the aging existing fiber, which is multi-mode and is end of life. See RFP for details and specifications.
- 2. White Pine School district is also requesting bids for connections from the District hub to all schools in the district, including leased lit fiber and Transport Only from 100 Mbps to 10 Gbps, depending on location, AND/OR leased lit fiber including Internet access and Internet Access and Transport Bundled from 20 Mbps up to 200 Mbps, depending on location.
